Details on 810 Air Parent Contribution Program

2025 – 2026 Training Year

What is the SCC and why do we need to fundraise?

The Air Cadet Program is jointly funded by the Government of Canada, through National Defence, and by parents and guardians through the Squadron Sponsoring Committees (SCCs). Every parent and/or guardian is a member of 810 Air Squadron by virtue of their child being a member of the Squadron. As parents, we are jointly responsible for providing approximately **\$100, 000** in fundraising each training year to support our cadets and their activities – about \$540 per cadet.

How much is the Bond?

We all have a role in achieving this fundraising goal. The bond amount for 2025 – 2026 training year will be \$300/cadet and additional \$200/cadet within same household.

At the time of registration, a bond amount of \$300 or dues per family will be required

- September registration: \$300 per cadet or dues per family
- January registration: \$200 per cadet

What if my Cadet quits during the year?

Registrations in September:

- Registration withdrawal before January, \$100 will be forfeited
- Registration withdrawal after January, \$200 will be forfeited

Registration in January:

- Any withdrawal, \$100 will be forfeited

- Pay the \$300 (or amount due per family) to opt out of any required commitment
- Donate \$300 (or amount due per family) and continue to support the squadron through volunteer/fundraising opportunities
- Fulfill equivalency of \$300 (or amount due per family) for return of bonds (with each commitment, we will return equivalency up to \$300 or dues per family) via eTransfer
